2.2 Report

2.2.1 Mr & Mrs Scrafton donation Clerk advised that a response was still required regarding the offer of a donation of a bench or other item for the community. She advised that the monies could not be held pending completion of the Nunthorpe Park and that the donor wanted an immediate project. Clerk to keep in contact with Mr Scrope the executor. **ACTION: Clerk**

2.2.2 Middlesbrough Council Documents – Members confirmed that they had no comments regarding the Community Involvement and Licensing draft policy.

2.2.3 Resident parking complaint – Clerk advised that she had forwarded this to Ward Cllr Rathmell and he had responded with an article on the Facebook Page. This brought back a number of complaints regarding the speeding and parking issues throughout Nunthorpe which will be progressed with Cleveland Police via Ward Cllr Rathmell and Cllr Wijesinghe. **ACTION: Ward Cllr Rathmell/Cllr Wijesinghe**

2.2.4 Resident complaint re Right of Way – Dixons Bank - Ward Cllr Rathmell stated that he has been in discussions with Middlesbrough Council regarding this Right of Way for a number of months. The Public Rights of Way Officer is aware that the path is in the wrong place. Cllr Leyland stated his support of the residents complaint, and felt that the diversion should be reinstated to where it was originally and any disturbance to the field be properly reinstated. Cllr Leyland proposed that letters be sent to Mr Muir Williams RoW Officer regarding reinstating the footpath and tidying the area as indicated in the definitive plan together a letter to Mrs Langley regarding the litter bin, seconded by Cllr Morrish and agreed by all. Cllr Harrison stated his thanks to Ward Cllr Rathmell for his persistence with this matter. **ACTION: Clerk**

2.2.5 Training Event Clerk enquired if any Councillors wished to attend the training session on Code of Conduct/Standards organised for the 18th November at 6pm, no Councillors wished to be booked onto this.

5.3 Clerk confirmed that the grant agreed at the last meeting for the Grumpy Gardeners was now being paid as the lawnmower and trimmer have been purchased. Cllr Leyland confirmed that this equipment is being kept at the school with safety equipment and are intended for use for any group, he extended this offer to the Nunthorpe in Bloom group.

5.4 Clerk confirmed that an email had been received from St Marys Church that she had responded to requesting a wreath directly from the Church for the War Memorial Service. She enquired if the amount was to be the same as donated to the Royal British Legion the previous year which Councillors confirmed. **ACTION:Clerk**

6.0: PROGRESS REPORT ON PROJECTS:

6.1 Notice boards – Clerk confirmed that this is being progressed with both the Supplier and via Middlesbrough Council for erection; however the costs were quite high, all members accept that a notice board is needed to communicate with the community members who do not have internet access.

6.2 Fireworks – Ward Cllr Rathmell confirmed that he had spoken with a fireworks provider and both he and Ward Cllr McGloin are progressing this. Cllr Tomlinson and Ward Cllr McGloin had spoken with the Recreation Club regarding the event and they were happy for this to be held on the site subject to a safety proposal, Ward Cllr McGloin progressing. The Clerk suggested that she would send a grant form to the Community Council as this would be the easiest solution for the joint event which had an anticipated cost of approx. £225 for each group.

6.3 Litter Bins – Clerk advised of emails from Middlesbrough Council that they would not provide bins and their offer to supply bins at a cost of £550 each. Ward Councillors to progress and following comments regarding the high rates paid by this area with nothing in return. Members asked for this to be an agenda item for November.

6.4 Public Telephone box - Mallowdale/Nunthorpe Village – Ward Cllr Rathmell advised that following discussions with British Telecom they confirm that in the last 3 years there has been no revenue from either telephone box. British Telecom state their view that they can be removed and reinstate the ground; a different option brought forward would be for the boxes to be taken over by the community to house defibrillators. This is the preferred option of both Ward Councillors. Members discussed that there were a lot of walkers in the area, but voiced concerns regarding vandalism and key holding however all were in agreement that it would be a good idea, Parish Councillors proposed that Ward Cllr Rathmell takes this forward and suggested that local groups were involved. They asked that he reports back when further details have been ascertained

ACTION: Ward Cllr Rathmell

6.5 War Memorial – Clerk updated Parish Councillors on details sent by St Marys Church which advise of a service commencing at the War Memorial at 10.50am on Sunday 8th November. Councillor Leyland advised that he was able to attend the service on behalf of the Parish Council for which all members thanked him. The Clerk confirmed that she would contact the Church to advise.

Members discussed that the Parish Council have supported the War Memorial for two and a half decades and stated concerns regarding comments made about the planting completed there. Parish Councillors thanked Cllr. Harrison and his wife Pauline for giving their time to ensure that the area was well maintained, and comments that they had visited the area and felt it was atmospheric and in keeping with the War Memorial. Ward Cllr McGloin believed that the Parish Council had stated they did not want help from the Nunthorpe in Bloom group, to which the Clerk read from the letter sent which only requested that any work is organised together. Cllr Leyland added that he is in

contact with the developer regarding ground levels around the Memorial and he felt that some plants will need renewing in the next few years.

It was suggested that Parish Councillors and the Nunthorpe in Bloom group visit the Memorial to progress this and to work together. **ACTION: Cllrs Leyland/Harrison & Ward Cllr McGloin (as part of the Nunthorpe in Bloom Group)**

7.0 WELCOME TO NUNTHORPE ROAD SIGNS:

8.0 IDEAS FOR IMPROVEMENTS TO THE PARISH COUNCIL:

Cllr Thomason said he was happy with the measures in place for administration and suggested that Doff Pollard from Tees Valley Rural Community Council is invited to a future meeting to discuss ideas for parish plans and see what other communities have done. All members agreed to progress this in the New Year.

9.0 ROADWORKS REPORT:

Cllr Leyland enquired if Ward Cllr Rathmell had received clarification from Middlesbrough Council regarding an up to date report on planned road works following 3 different reports over an eighteen month period. **ACTION: Ward Cllr Rathmell**

10.0 NEW HOUSING DEVELOPMENTS (LOCAL FACILITIES/ ROAD CONGESTION/ SAFETY):

10.1 Members discussed the Gypsy Lane closure a number of years ago under questionable circumstances and the development of hundreds of new houses around the area, which runs into 1500 new houses within the next 5-10years. Cllr Harrison proposed that a letter is sent to Redcar and Cleveland Council about reopening Gypsy Lane. He added that Middlesbrough Council had blocked the East Cleveland bypass with the approval of the Low Gill development. Redcar & Cleveland Council also blocking with the proposal for homes at Swans Corner. Seconded by Cllr Leyland and agreed by all. **ACTION: Clerk**

10.1.1 Cllr Thomason enquired if members thought that it was worthwhile pursuing the issue of parking problems around Nunthorpe including parking at Nunthorpe Recreation Club. He enquired if emergency vehicles were known to use Guisborough Road in favour of the bypass. Councillors asked that this subject be addressed on the next agenda and asked the Ward Councillors to make a presentation. Members discussed the idea of reinstating a highways group to deal with traffic / highways issues. **ACTION: Ward Cllrs/Nov Agenda**

10.1.2 Ward Cllr. McGloin added that local parking near the sports field had been an issue for years and is regularly discussed at the Community Council meeting and was discussed at the last Playing Fields Association meeting. She said that police are aware of issues within Nunthorpe.

Ward Cllr Rathmell added that he had contacted 2-3 authorities and he had attended site visits, fines had been handed out. Cllr Leyland asked if the correspondence can be forwarded to the Parish Council. **ACTION: Ward Cllr Rathmell**

11.0 STREET LIGHTING REPLACEMENT:

Cllr Leyland proposed that a letter is sent to Middlesbrough Council asking what their proposed replacement programme is. Agreed by all **ACTION: Cllr Leyland/Clerk**

12.0 UPDATE ON NUNTHORPE PARK:

Still being progressed. Middlesbrough Council continues to delay meetings. Ward Cllr McGloin to speak with the department involved whilst in the Town Hall.

13.0 POLICING IN NUNTHORPE/PARKING IN NUNTHORPE/ SCHOOL CROSSING:

13.1 Cllr Tomlinson confirmed that Cllr Thomason and Cllr Wijesinghe are going to be involved with observing the police and visiting the control room together with a trip with the police to the town centre to observe the night time policing requirements. Ward Cllr Rathmell confirmed that a date should be organised for this within the next four weeks. He added that this offer of involvement with Cleveland Police is being offered now across the district. This project has the full support of the Parish Council.

13.2 Parking and speeding issues – Ward Cllr Rathmell is awaiting a meeting date from Cleveland Police. All agreed that Cllr Wijesinghe attends on behalf of the Parish Council. **ACTION: Ward Cllr Rathmell**

14.0 PLANNING:

Review of previous applications: A Report summarising the status of previous applications compiled by the NPC Advisor was circulated in advance of the meeting. Applications were brought to the attention of the full NPC requiring discussion/decision.

Planning Applications;

143 Guisborough Road – Application to change from a flat to a pitched roof– No objections.

38 Moor Park – No objections, proposal can't be observed from the road.

32 Connaught Road – Members agreed no objection as there was no more detrimental effect on the neighbours than the last application.

80 Cookgate – Cllr Tomlinson advised that despite very detailed letters being sent, there had been no response from the Mayors office and a very unsatisfactory reply from Mr Sheppard regarding the unregistered land. Ward Cllr Rathmell clarified that the meeting planned for Friday 9th October is regarding the fences and the change of use for the land.

He advised that the decision on the unregistered land was passed on 22nd September through an Executive sub group and an objection can only be done by calling in and then goes to a scrutiny panel. He would need to find 5 other Ward Councillors willing to object.

Cllr Harrison stated his objection to the executive sub committee meeting happening without the Parish Council being informed.

Ward Cllr Rathmell advised that he has lodged an objection through the land registry regarding the ownership of the land. The resident has also been served with a definitive map preservation order. Ward Cllr Rathmell added that the resident has held discussions with Middlesbrough Council regarding planned extensions.

Members discussed that the Council have maintained the land since the 1970s.

Cllr Leyland said that he would like to see records of the discussions with the planning department and would like to ask the mayor for meeting and consider claiming land on behalf of community. Ward Cllr McGloin advised that as a member of the planning committee her views would be heard prior to the meeting. Ward Cllr Rathmell felt that in respect of the Estates Dept they won't make a legal claim for the land and wont refuse applicant. All members felt that a "reasonable person" on the committee should not allow a change of use and will request the fence to be removed as it is not in keeping with the area.

Members all agreed actions to make a freedom of information request from May 2015 onwards for any information relating to 80 Cookgate from officers Paul Clarke, Tim Wake Cllr Rooney and the Mayor. Also to request a meeting with the Mayor and a meeting with council officers to discuss and challenge the policy on unregistered land in Nunthorpe and across Middlesbrough. Clerk to obtain and circulate the minutes of the meeting held on 22nd September. **ACTION: Clerk**

14.2 Planning procedures - Members to discuss further ideas for progressing the planning procedures of the Parish Council.
